The main storage is HPE 3PAR Storage, supported by flash and predictive analytics to deliver high availability. Virtual desktops and apps are delivered to all locations using the high-performance Horizon workspace that streamlines environment management and helps IT control, manage, and protect all of the Windows resources needed by each branch, delivered through a single platform. To free up space and increase reliability and security for equipment, network and server operations offsite to free up space and budget.
